Zoom Instructions for Participants

To join the conference by phone:

- On your phone, dial the teleconferencing number provided below.
- Enter the **Meeting ID number** (provided below) when prompted using your touch-tone (DTMF) keypad.

Before a videoconference:

- You will need a computer, tablet, or smartphone with speaker or headphones. You will have the opportunity to check your audio immediately upon joining a meeting.

Participant controls in the lower left corner of the Zoom screen:

- View Participant list opens a pop-out screen that includes a "Raise Hand" icon that you may use to raise a virtual hand during Call to the Public (or *9 if using touchtone phone only)
- Change your screen name that is seen in the participant list and video window
- Share your screen

On your Zoom screen you will also see a choice to toggle between "speaker" and "gallery" view. "Speaker view" shows the active speaker. "Gallery view" tiles all meeting participants.
